# 2015 AGM details

The State Committee of Management has resolved to hold the 105<sup>th</sup> AGM commencing Wednesday 28 October 2015 at the Union Office, 1 – 7 Belmore Street Surry Hills. The AGM Agenda is attached.

The **opening section** will be held on Wednesday 28 October commencing 1000 hours at the Union Office, 1 – 7 Belmore Street Surry Hills. Members are reminded that in accordance with Rule 11, the opening section of the AGM is the only meeting at which motions may be amended. The **closing section** will be held on Wednesday 4 November at 97 Station, Huntingwood, commencing 1800 hours.

**Retained** and/or **Country** Sub-Branch members may meet locally (but once only) prior to 1500 hours on Wednesday 4 November provided that:

- a) a quorum of least seven financial Union members will be present throughout the course of the meeting; and
- b) written notice of intention to hold a meeting together with the proposed time, date and location is received by the Union office by no later than 1700 hours on Thursday 15 October.

A full and final list of all Sub-Branch meetings to be held across the state (including Central Coast, Illawarra, Newcastle and Sydney Sub-Branches) will be published in SITREP 34 on Friday 16 October.

# MFR sub-committee report available

The report of the Union's MFR sub-committee that was first announced in SITREP 18 is now available via the online version of this SITREP. The report is also listed at AGM agenda item no. 5.

# **Review of LF and LSO selection processes**

The recommendations arising from the State Committee's review into the LF selection processes that was first reported in SITREP 20 is also now available and, like the MFR sub-committee's report above, is also on the AGM agenda. It had been intended that this would be a joint FBEU/Department review, but aside from conducting a brief online survey of its own that it has since done nothing with, the Department's inaction left the State Committee's was left with no option but to publish solo. The State Committee's 24 recommendations arising from that review can be found on the online in this SITREP, and will be considered at AGM agenda no. 6.

# 2016 Award claims

The AGM Agenda released today refers at motion 1 to the Union's 2016 Retained Award claim, and at motion 2 to the 2016 Permanent Award claim – in each instance to a draft award "*that was posted to the Union's website on 2 October 2015*". Motions 3 and 4 also refer likewise. The reason for this delay is that with negotiations scheduled for next week, any document released today was likely to be superseded within a week. The final documents that members will be asked to endorse will therefore be released next Friday, 2 October with SITREP 32, thereby still allowing a full four weeks prior to the vote.

### 7. Amendment of policy on UFUA funding

"That the April 2010 Special General Meeting decision to cease UFUA funding that currently reads:

'That effective on and from 1 July 2010, the Union is to cease forwarding any funds to the United Firefighters Union of Australia and/or its NSW Branch until authorised otherwise by a further General Meeting of members.'

### be amended to now read as follows:

'That effective on and from 1 July 2010, the Union is to cease forwarding any funds to the United Firefighters Union of Australia and/or its NSW Branch unless and until:

- 1) the NSW Branch is unable to meet a debt that is ordered by a court of competent jurisdiction to be paid, in which case the FBEU shall forward such amount to the NSW Branch as is necessary for the NSW Branch to comply with that order; or
- the Fair Work Commission certifies amendments to the UFUA's Rule 29 (Moneys Allocated to National Fund) and Rule 34 (National Levies) that:
  - a) limit quarterly payments to the National Fund under Rule 29 to 10% of one financial unit for each full time member, and to 2% of one financial unit for each part time member; and
  - b) fix a "financial unit" at 5% of the weekly rate of pay of an FRNSW Senior Firefighter, rounded up to the nearest whole dollar; and
  - c) prevent the future imposition of national levies under Rule 35 without the approval of every Branch; and
  - d) prevent the future amendment, alteration or rescission of Rules 29 and 35 without the approval of every Branch. ""

### 8. Appointment of Returning Officer

"That in accordance with Rule 22(1), this meeting appoints Comrade Travis Broadhurst as Returning Officer for the ensuing three years through until the Union's 2018 Annual General Meeting."

### 9. Life Membership – Comrade Matthew Murray (Rule 52)

"That in recognition of the significant contribution made by Comrade Matthew Murray as both an FBEU representative (Sydney South West Sub-Branch Secretary from February 2002 to June 2009, Organiser from February 2002 to December 2003, Death and Disability Superannuation Fund Director from 2010 to 2013 and Junior Vice President from June 2009 to April 2015) and as a tireless fighter for working people and union rights in a 37 year career across three fire services, this meeting resolves to admit Comrade Murray as a Life Member of the Union in accordance with Rule 52 (1)."
