Part F. Qualifications to hold office and,	/or nominate			
Candidates must be financial members of the Fire Brigade Employees' Union of NSW and must be nominated in writing by at least two (2) financial members (other than the candidate) of the Fire Brigade Employees' Union of NSW.				
A candidate may not contest more than one (1) Officer position. Where a member is nominated for more than one Officer position the Returning Officer will invite the member to withdraw their multiple nominations so as to limit their nominations to one position. If the member fails to do so before the time stipulated i.e. 12 noon, Friday 22 March 2024, all nominations for that member shall be deemed to be withdrawn.				
A member nominating for election to a Sub-Branch Secretary's position (except the positions of Senior Officers' Sub-Branch Secretary and Retained Sub-Branch Secretary) shall be a permanent firefighter holding the rank of Station Officer or below, or a firefighter employed in the private sector, and in either case shall be employed within the region or area of that Sub-Branch.				
A member nominating for election to the position of Senior Officers' Sub-Branch Secretary shall be employed as a permanent firefighter holding a rank above the rank of Station Officer.				
A member nominating for election to the position of Retained Sub-Branch Secretary shall be employed as a retained firefighter. Each Sub-Branch Secretary's position shall be elected in a separate ballot. All members shall participate in the election of each of the Sub-Branch Secretaries.
