You will be advised of the status of your nomination as soon as it is received by the NSW Electoral Commission. However, it is the responsibility of the candidate to ensure that the nomination form has been received by the NSW Electoral Commission.

A candidate wishing to withdraw their nomination must do so in writing to the Returning Officer by **12 noon, Friday 27 September 2024**. A nomination cannot be withdrawn after this time.

## Part F. Qualifications to hold office and/or nominate

Candidates must be financial members of the Fire Brigade Employees' Union of NSW and must be nominated in writing by at least two (2) financial members (other than the candidate) of the Fire Brigade Employees' Union of NSW.

A member nominating for election to a Sub-Branch Secretary's position (except the positions of Senior Officers' Sub-Branch Secretary and Retained Sub-Branch Secretary) shall be a permanent firefighter holding the rank of Station Officer or below, or a firefighter employed in the private sector, and in either case shall be employed within the region or area of that Sub-Branch.
