Thank you for your recent correspondence detailing the needs and concerns of firefighters throughout the state.

I am pleased to confirm a future Daley Labor Government will commit to ensuring no staff reductions occur in Fire and Rescue NSW. In addition to maintaining staffing levels, a Daley Labor Government will commit to employing 200 extra firefighters across NSW in order to keep up with the growing demand placed on our state's firefighters.

This provision of additional firefighters will allow for communities in areas such as Ballina, Salamander Bay and Western Sydney to fill the gaps in order to finally maintain permanent 24/7 facilities to service the ever-increasing population growth in these areas.

A Daley Labor Government will have a wages policy that is fiscally and economically responsible, but which is also fair. In government, Labor will develop a principled and collaborative framework for dealing with claims by workers and unions for improved pay and conditions, with an appropriate role for the independent umpire, the Industrial Relations Commission of NSW.

To go beyond the 2.5 per cent, the drivers will be workplace change, improvements in service delivery and increases in productivity - outcomes that lift the quality of the services being delivered to the community and which improve the workplace.

At present, there is no incentive for the workforce or management to make improvements in the way work is done and the way services are delivered to the wider community. We will change that. Under a Daley Labor Government the drivers will be workplace change, improvements in service delivery and increases in productivity – outcomes that lift the quality of services being delivered to the community. Continuous improvements in the skills of the workforce will be part of that.

A Daley Labor Government would also welcome ongoing consultation and discussion with Fire & Rescue NSW and the FBEU with regards to any major issues or changes to the scope and nature of the duties NSW firefighters perform.
