All voting material will be posted on that day to each financial Station Delegate's postal address, being the address held in the Union's membership records at that time, and all ballots will close at 5.00 pm on Monday 14 April 2025.

Counting of ballot papers shall take place in the Union office commencing at 11 am Tuesday 15 April 2025. Candidates may nominate a scrutineer to observe the counting of the ballot, provided that such scrutineers are financial members of the Union and have with the written authority from that candidate to act on the candidate's behalf.
